

In case, on the day of inspection the University Examinations are in progress at the affiliating college, you are also requested to monitor the process of examination at the centre with minimum disturbance to the examination system and to the students.

The Principals of the Constituent Colleges / Directors of the University as the case may be, are requested to make the payment of advance to the Convenor / Individual concerned and claim the reimbursement of the consolidated amount from the University by submitting the statements of expenditure.
