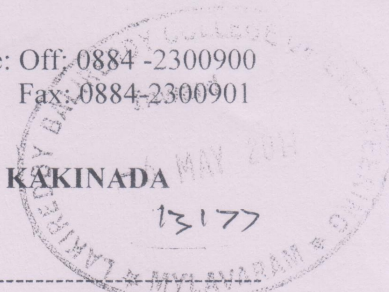

**ORDER:**

1. The “Lakireddy Balireddy College of Engineering, Mylavaram, Krishna District, Andhra Pradesh” was given temporary affiliation for running UG/PG courses during the academic year 2009-10 vide Procs.(1) read above.
2. The AICTE, New Delhi and Government of AP have accorded extension of approval to the above college for the academic year 2010-11 vide ref.(2) and (3) read above. The University has constituted a Fact Finding Committee to verify the staff and infrastructures facilities of the college to consider the grant of Permanent affiliation from the academic year 2010-11 vide Procs. (4) Read above. The Fact Finding Committee has visited the college and submitted its report to the University and the same was placed before the Affiliation Committee vide ref.(5) read above. The Affiliation Committee has verified the report of the Fact Finding Committee and other documents and made recommendations for affiliation from the academic year 2010-11.
3. Under the circumstances as stated above, the Vice-Chancellor is pleased to grant **Permanent Affiliation** to “Lakireddy Balireddy College of Engineering, Mylavaram, Krishna District, Andhra Pradesh” sponsored by “Lakireddy Balireddy Charitable Trust, Mylavaram, Krishna District, Andhra Pradesh” to offer UG/PG Courses in the following disciplines with the intake shown against each for the period of **Three Years** from the Academic Year 2010 – 11 as detailed below:




The Permanent Affiliation shall be subject to the following conditions:

1. The management shall follow the norms of AICTE and rules of the affiliation of JNT University in all aspects.
2. The management shall follow the Academic Regulations and examination schedule of JNT University.
3. During the period of Permanent Affiliation, the College needs to submit annual report along with Affiliation fee. During the period of Permanent Affiliation the College is exempted from the payment of Application & Inspection fee.
4. The University can withdraw the Permanent Affiliation at any time, if the College does not satisfy the standards and norms of the University for Affiliation.

However, the above College is being granted Temporary Affiliation to the following two PG Courses with the intake shown against each for the Academic year 2010-11.
