Each Party will ensure appropriate protection of Intellectual Property Rights generated from cooperation pursuant to MoU, consistent with their respective laws, rules and regulations and international agreements to which both parties are committed. In case of joint publication, the use of the name, logo and/or official emblem of the participants on any publication, document and/or paper will require prior permission of both the participants. Further, the Parties shall not assign any rights and obligations arising out of the IPR generated from inventions/activities carried out under the MoU to any third Party without consent of the other party.

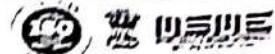
Commercialization of technology in any other country shall be done jointly through a separate agreement. All Confidential Information shall remain the exclusive property of the disclosing party.

Each institution shall appoint one member of its teaching/research faculty/staff to coordinate the programme on its behalf. The coordinator, thus appointed, will periodically review and identify ways to strengthen cooperation between the two institutions.

This MoU will take effect from the date it is signed by representatives of the two institutions. It will remain valid for **two years**, and may be continued thereafter after suitable review and agreement. Either of the parties may terminate the MoU by giving written notice to the other party, three months in advance. Once terminated, neither **LAKIREDDY BALIREDDY COLLEGE OF ENGINEERING** nor **LINEYSHA AND THEVAN SOFTWARE TECHNOLOGIES PVT LTD** will be responsible for any losses, financial or otherwise, which the other institutions may suffer. However, **LAKIREDDY BALIREDDY COLLEGE OF ENGINEERING** and **LINEYSHA AND THEVAN SOFTWARE TECHNOLOGIES PVT LTD** will ensure that all activities in progress are allowed to complete successfully.
