Terms & Conditions:

1. Nature of Relationship

- b) This MOU shall be valid for 2 years from the date of MOU and each party shall be at full liberty to terminate the collaboration with a notice period of 3 months.

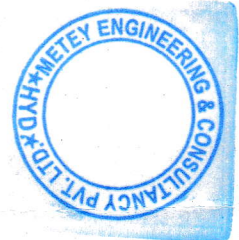
